2. Data protection and data management information

3. Technical tools for operating the website

The anonymous visitor ID, as a string of signals (cookie), cannot in itself identify the customer, i.e. the visitor, in any way, it is only suitable for recognizing the visitor's computer. The user has a way to set his browser so that it does not allow the placement of the unique identification mark in the to the user's computer (depending on the browser, usually in the tools menu under settings/internet settings). In this case, the user can use a significant part of the service in the same way, but in some cases (for example, in the case of customized solutions), the user cannot use some functions of the service to the fullest extent.

Google Analytics

Balázs Ivett E.V. The Pille Physiotherapy company uses the Google Analytics program primarily to generate statistics, among other things, it measures the effectiveness of its campaigns. By using the program, Balázs Ivett E.V. The company Pille Physiotherapy mainly obtains information about how many visitors visited its website and how long the visitors spent on the website. The program recognizes the visitor's IP address, so it can track whether the visitor is a returning or a new visitor, and it can also be tracked how the visitor traveled on the Website and where they entered.

4. Scope of managed data and purpose of data management

In the case of mandatory data provided by the user, the purpose of data management is to identify the user's authorization. The Service Provider deletes the data within 5 working days from the receipt of the deletion request. In case of deletion, the displayed data cannot be restored. At the request of the user, we provide information about the personal data of the user or modify or delete the data at the request of the person entitled to it.
